

Early Bird Back-to-School Uniform Credit

Terms & Conditions

Ellis Scott Schoolwear

- Early Bird Back-to-School Uniform Credit is available for purchase online only at ellisscott.co.uk.
- The Early Bird offer runs for one month only during May (exact dates will be published on the website).
- The minimum purchase value is £50.
- The maximum purchase value is £250 per child.

Extra Credit Top-Up

- When Early Bird Uniform Credit is purchased, Ellis Scott Schoolwear adds additional credit to the value purchased.
- The additional credit is applied automatically at the time of purchase and is conditional on early use.

Use of Early Bird Uniform Credit

- Early Bird Uniform Credit is redeemable against back-to-school uniform packages only.
- It cannot be used for individual uniform items, shoes, accessories, clearance or sale items, or to purchase additional gift cards.

One Per Child – Fair Use Policy

- Early Bird Uniform Credit is limited to one gift card per child / per school place.
- Families with more than one child may purchase one Early Bird Uniform Credit per child, subject to the maximum value per card.
- Multiple Early Bird gift cards may not be combined or redeemed against the same child or the same uniform package.
- Ellis Scott Schoolwear reserves the right to request confirmation of the child or school at the point of redemption.

Package Ordering & Collection

- Uniform packages will be available to order from May through to the end of July.
- Packages purchased using Early Bird Uniform Credit are prioritised for early collection, with the aim of being ready by the end of July.

Exchanges Due to Growth

- Items purchased as part of a back-to-school uniform package may be exchanged up to the day before the child's school term begins.
- Items must be unused, in sellable condition, and returned with all original labels and tags

intact.

- Exchanges are subject to stock availability.
- Items showing signs of wear, washing, or damage cannot be exchanged.

Remaining Balance & Use After July

- Early Bird Uniform Credit includes an additional credit top-up added by Ellis Scott Schoolwear and is intended for early use towards a uniform package.
- If Early Bird Uniform Credit is not used to purchase a uniform package by the end of July, the additional Early Bird credit top-up will be removed.
- The remaining balance will revert to the original amount paid and will remain on the gift card as a standard Ellis Scott Schoolwear gift card, redeemable in line with standard gift card terms.

General

- Early Bird Uniform Credit is not redeemable for cash and is non-refundable.
- Gift cards are issued digitally by email – please allow up to 48 hours for delivery and check spam or junk folders.
- Standard Ellis Scott Schoolwear gift cards are available all year round without the Early Bird top-up.
- Ellis Scott Schoolwear reserves the right to amend or withdraw this offer at any time.
